Upon such presentation and subject to our review and agreement, we shall endorse and forward this Letter of Credit to the designated transferee, provided that this Letter of Credit may not otherwise be amended or modified without consent from us, you and the Applicant, and, except as otherwise expressly stated herein, is subject to the Uniform Customs and Practice for Documentary Credits -2007 Revision, ICC Publication No. 600, or any successor publication thereto (the "UCP").
